# Annual Report 2019/20

## Working Together to End Violence Against Women and Girls

### Violence Against Women and Girls includes:

- *domestic abuse;*
- *rape and sexual assault;*
- *childhood sexual abuse (including incest);*
- *sexual harassment and intimidation at work and in public spaces;*
- *commercial sexual exploitation and prostitution;*
- *pornography;*
- *trafficking for the purposes of sexual exploitation;*
- *dowry-related violence;*
- *harmful practices (including female genital mutilation, forced marriage, child marriage and 'honour' crimes.*

## Domestic Abuse

**In 2019/20 there were 1,245 incidents of domestic abuse reported to the police, an increase of 51 over the previous year. After enquiries, 45% of these were confirmed as crimes.**

### Victim Support Scotland

Victim Support Scotland offers support to all victims of crime regardless of whether this has been reported. In 2019/20 the Perth & Kinross team supported **55** victims of domestic abuse. Staff and volunteers also provided emotional support and practical advice in **24** rape cases and **29** sexual offence cases. Support was provided at Perth Sheriff Court when witnesses attend to give evidence. Giving evidence causes victims to relive the crime committed against them. Victim Support Scotland also support family and friends of victims of domestic abuse and sexual violence on how best to support their loved one.

**MARAC**, the Multi-Agency Risk Assessment Conference, meets monthly to discuss the best way to keep the highest risk victims of domestic abuse and their families safe. Safety Plans were developed for each victim and **59** cases were discussed by the Perth MARAC - a decrease of **3** on last year. **59** women and **98** children were covered by safety plans.

Barnardo's work in partnership with Police Scotland throughout the whole Tayside region. Barnardo's supports individuals and families to live without fear and reduce the impact of Domestic Abuse. Based at Perth Police Station, trained specialists support those affected by domestic abuse through safety planning, risk assessment and emotional and practical support. **45** women received 1:1 support and **2** women were provided with professional 1:1 counselling.



PWA received **329** referrals about Domestic Abuse.



- **197** to Advocacy Service.
- **374** to Women's Support Services.
- **94** to Counselling/**72** women offered counselling.
- **21** to refuge/**14** women supported in refuge with **16** children.
- **4** women identified with no recourse to public funds.
- **329** women in service supported.
- **251** children linked to women supported.



### PKC Housing

A safe home is vital in supporting women fleeing from domestic abuse and working with Perthshire Women's Aid, PKC Housing have supported **70** households who were made homeless through domestic abuse. **44** households were permanently rehoused, **4** returned home, **1** moved to supported accommodation, **2** secured private lets, **9** made other arrangements.

At present there are **61** households identified as having strategic needs and **22** of them cite domestic abuse as a reason for applying for rehousing.



Cedar continued to provide support to families recovering from Domestic Abuse throughout Perth and Kinross.

The therapeutic 12-week group work programme is delivered in central Perth with children coming from across Perth and Kinross. Mums attend a parallel group work programme to support their children:

- **2 Mums' Groups - 13 Mums attending, and 10 Mums receiving 1-1 support who were not able to attend group.**
- **6 Children's Groups for children aged 5-12 years and 1 Teenagers' Group.**

CEDAR also piloted an Emotional Wellbeing Group which ran over 6 weeks and was attended by **7** young people who attended secondary school:

- **84 Assessments were carried out with Mums and their children prior to group. This is an integral part of ensuring that the group is right for the family and helps to build the relationship prior to group.**
- **6 families supported with extra 1-1 support for the children who were attending the group work programme.**
- **16 Awareness-Raising Sessions on Domestic Abuse and Healthy Relationships were delivered to local high schools for pupils in Year 4.**

## Sexual Violence



**67** rapes were reported to Police Scotland in Perth and Kinross, a reduction of **9** on 2018/19. The offender was detected in **43** of these crimes, a detection rate of **64.2%**. For the same period these were **122** sexual assaults reported a reduction of **14** crimes over the previous year.

There has been a **95%** increase in survivors accessing support over the last 5 years.

- **45%** self-referrals received.
- **42%** of referrals are from under 25s.



### RASAC Prevention Services

- Delivered **442** sexual violence workshops to **6463** pupils.
- Involved **442** young people and **68** adults in community sessions/workshops.
- Supported **23** RASAC Youth Ambassadors (up to age 18).
- Supported **5** older Student Volunteers (age 18+).
- Delivered **18** Training Sessions to **338** professionals working in Perth and Kinross.



# Events Held in Perth and Kinross

## Solheim Cup

**9-12 September**

*Gleneagles Golf Resort*

The Solheim Cup was held at Gleneagles in September, pitting a team of Europe's top female golfers against their US counterparts. The biennial tournament provided a major uplift for the local economy, attracted a global TV audience in the hundreds of millions and nominated Perthshire Women's Aid to benefit as its local charity partner.

Speaking at the launch event Interim manager for PWA Heather Williams said: *"We believe this will be a fantastic platform to ensure a wide audience are aware of the life changing services we offer to women, children and young people with experience of domestic abuse."*

*"Having the opportunity to be involved in an event which celebrates women's sporting achievements fits with PWA's vision of an equal society where women and girls live lives free from abuse."*



## My Mind is Free

**Monday 21 October**

*Joan Knight Studio, Perth Theatre*

Over 200 people from a wide variety of professions and interests attended an event to raise awareness of modern-day slavery. The event by the Rah Rah Community Theatre Company

was followed by presentations from Bronagh Andrews from the charity TARA and Detective Chief Inspector Graham Binnie, who spoke about their experiences of trafficking locally and what to look out for.

The production used imaginative physical theatre and role playing to

tell the interlinked stories of four people trafficked to and within the UK and their account of abuse, exploitation and enslavement.

The presentations were followed by questions to the actors and presenters and lively audience discussion.

## Report on 16 Days of Activism Events 2019

*24 November - 10 December*

**Friday 22 November**

**16 Days Launch - Preview of Events with John Swinney MSP, Deputy First Minister**

*Perthshire Women's Aid*

Mr Swinney met Partnership members at the offices of Perthshire Women's Aid. The programme of events over the 16 days was discussed with him and he reaffirmed his support for the work of the Partnership.



**Tuesday 26 November**

**16 Days Question Time**

*Joan Knight Studio, Perth Theatre*

This event focussed on the challenges facing the criminal justice process in cases of violence against and in meeting the needs and expectations of victims and survivors. An audience of 140 heard from Detective Inspector Paul Boath on the prevalence of

domestic abuse and the resources that Police Scotland commit to training, investigation and support. Anne Marie Hicks spoke of the prosecutions need to balance the public interest against individual choice - disengagement of victims and changes of mind was often further evidence of coercive control and the requirements of corroboration often prevent prosecutions taking place. Sheriff Alastair Duff explained the judges role in the court process - limited to adjudicating solely on the evidence placed before the court - and then went on to explain the extensive training judges receive on the nature of gender-based violence so they can better understand the mindset and demeanour of the victim in court and deal with them in an empathetic way.

Tom Simmons, a prison-based criminal justice social worker spoke on the difficulties of working with prisoners - there is no formal gender-based programme for partner violence - as the consent and participation of the prisoner is required. Much of the work is focussed on working with prisoners as they are about to leave prison and multi-agency working to ensure the safety of partners and families. Rory Macrae spoke about the Caledonian Programme, which requires men to deal with

their offending behaviour as an alternative to imprisonment. He gave some personal insights gained over many years and remains convinced that men are the solution to GBV and that, far from gaining satisfaction from their behaviour, they remain a very unhappy, frustrated group of individuals.

Following the presentations, the Chair, Ann Hamilton, invited questions from the audience and there then followed a lively debate involving all the panel members and the audience.

## Wednesday 27 November

**MARAC Development Day**  
*Deaf Hub, The Old Mill,  
23 Brown Street, Dundee*

The three Violence Against Women Partnerships across Tayside, Perth, Dundee and Angus, came together to hold a development day for the Multi-Agency Risk Assessment Conference partners who work together to risk assess and provide safety plans for women and families most at risk from violent partners. The event, which was attended by about 50 partners, discussed roles, representation and responsibilities and developed plans for consolidating the work of MARAC into the future.

## Thursday 28 November

**Kaleidoscope - Naomi Breeze**

*Lecture Theatre, Art Gallery & Museum, Perth*

Naomi Breeze is a celebrated actress who writes and performs one-woman shows on a variety of topics. Kaleidoscope tells Chrissy's story which Naomi has drawn from research with women supported by Scottish Women's Aid and covers a wide range of abusive and controlling behaviours experienced by many. Powerful and compelling this play got to the heart of abuse and control in an intimate relationship and should be compulsory viewing for anyone wanting to know more about the impact of domestic abuse.

## Thursday 28 November

**Perth Film Society -  
Thelma & Louise**

*Joan Knight Studio, Perth  
Theatre*

In association with Perth Film Society, 140 society members and members of the public were addressed briefly by Jen Stewart, RASAC P&K, and John Evans, PKVAWP, on the issues of gender-based violence in Perth and Kinross - issues which are prominent in the film and have a direct bearing on the journey and the outcome for Thelma and Louise. When viewed through this "gendered lens" the film remains superb entertainment but brings the consequences of domestic abuse and sexual violence into sharp focus.

### Thelma & Louise

*Birks Cinema, Aberfeldy*

The film was shown to an audience of about 40 in Aberfeldy, most of whom met for coffee and a discussion after the showing.

## Wednesday 4 December

### Seminars - Perthshire Women's Aid

*Civic Hall, 2 High Street, Perth*

#### Identifying Risk & Safety Planning

#### Domestic Abuse (Scot) Act 2018

Heather Williams, Perthshire Women's Aid, led both seminars, with the audience comprising about 30 individuals from a wide variety of backgrounds - health, social work, housing, women's support services. She drew on her wide experience of supporting survivors of domestic abuse to help identify risk factors for women and families and the participants took part in practical group exercises to formulate appropriate safety plans.

In the afternoon she explained the provisions of the new legislation in some detail. Scotland is now one of the few countries in the world which recognises that a pattern of coercive control - whether by violence, psychological, emotional, or financial means - constitutes the crime of domestic abuse.

## Thursday 5 December

### An Audience with Dr Graham Hill

*Joan Knight Studio, Perth Theatre*

Dr Graham Hill is a skilled and highly engaging speaker with a background as a senior detective with the Metropolitan Police and,

following retirement, as a widely respected researcher, lecturer and consultant. This lecture formed a key element of the 16 Days of Activism in 2019 as part of the challenge to understand why men feel the need to exercise power and control over women in order to support women more effectively and keep them safe. This topic is of great interest to those working to address gender-based violence and around 140 were present in the Joan Knight Studio.

Dr Hill drew parallels between the motivations of child sex offenders and men who engage in more widespread forms of violence against women. The vast majority of offenders have a significant life event/s (ACEs) and how they respond to that will determine how they manage their intimate relationships.



As many who have worked with abused women know, Dr Hill confirmed that *"the best predictor of behaviour is past behaviour"* and this must always be a key element in safety planning.

## Thursday 5 December

### Thursdays in Black

*High Street, Perth*

A small group joined together in Perth High Street to demonstrate solidarity with thousands worldwide who wear black every Thursday and speak out against all forms of gender-based violence.



This has become an annual event in the PKWAWP 16 Days of Activism.

## Thursday 5 December

### Reclaim the Night

*Perth City Centre*

Another fixture in the 16 Day activities is the Reclaim the Night event. This year, on an extremely inclement night, about 100 women, children and men gathered in the Civic Hall, 2 High Street and then walked on a circular route through the city centre to reclaim the night from violence and intimidation. Similar events occur in towns and cities throughout the world demonstrating that violence against women is an international issue.



## Monday 9 December

### Practitioner Development Seminar

*St John the Baptist Church Hall, Princes Street, Perth*

Bishop Ian Paton addressed the group on issues for the church in dealing with domestic abuse and sexual violence. There followed a lively discussion and a view that, to remain members of the church community many *"women of faith"* were prepared to, or required to, *"live under a tyranny of respectability"*. Linda Thompson, speaking on prostitution and commercial sexual exploitation, and Dr Lesley Orr, considering the importance of research in informing practice in supporting survivors of sexual violence, both emphasised the importance of learned experience and the need to listen to the voices of victims.
